### Texas Archaeological Repository Group (TARG)

A new community of archaeologists and curators of archaeological collections has been formed. This group will endeavor to provide help and assistance to its members as we all navigate the world of caring for collections without resources in a time of increasing demands to have data at our collective fingertips for researchers. This group will work together to create shareable inventories structures to further research and create a state level Native American Graves Protection and Repatriation Act (NAGPRA) practitioners group.

The initial meeting of TARG brought together a small group of people for discussion but represented the larger and older institutions in the state of Texas: including TARL, the THC, the Witte, and Panhandle Plains museum. We have setup a Cloud based storage in order to share files and work collaborating on topics of interest.

Action items for the rest of the year for the TARG are: establishing networks, helping each other handle issues, state level of NAGPRA practitioners, and getting out of our silos and being a community.

# Available Grants and Funding

#### American Alliance of Museums

Museum Assessment Program offers five assessments: Organizational, Collections Stewardship, Education & Interpretation, Community & Audience Engagement, and Board Leadership. Through a Cooperative Agreement with the Institute of Museum and Library Services, AAM is able to offer assessments at a low cost to museum that meet the eligibility criteria.

Application deadline is September 1, 2021 with varying participation fees depending on institution size.

#### **National Endowment for the Humanities**

Infrastructure and Capacity Building Challenge Grants strengthen the institutional base of the humanities by enabling infrastructure development and capacity building. Awards aim to help institutions secure long-term support for their core activities and expand efforts to preserve and create access to outstanding humanities materials. The program funds two distinct types of projects: Capital Projects and Digital Infrastructure.

Application deadline September 28, 2021 and a maximum award amount of \$750,000

<u>Humanities Collections and Reference Resources</u> supports projects that provide an essential underpinning of scholarship, education, and public programming in the humanities. This program strengthens efforts to extend the life of cultural materials and make their intellectual content widely accessible, often through the use of digital technology. Awards are also made to create various reference resources that facilitate use of cultural materials, from works the provide basic information quickly to tools that synthesize and codify knowledge of a subject for in-depth investigation Application due July 15, 2021. Maximum award amount for Implementation projects \$350,000 and \$50,000 for Foundations projects.

Archaeological and Ethnographic Field Research program makes awards to institutions and organizations conducting empirical field research to answer significant questions in the humanities. Archaeology and ethnography are important methodologies utilized by many disciplines across the humanities and social sciences that provide observational and experiential data on human history and culture. Projects may be led by individuals with institutional affiliation or by teams of collaborating scholars from the same or multiple eligible institutions. Awards provide up to three years of support for fieldwork and data processing.

Application available July 29, 2021 with a deadline of September 29, 2021. Maximum award amount is \$150,000.

## **Institute of Museum and Library Services**

American Rescue Plan Act Grants enable libraries, museums, federally recognized tribes, and nonprofit organizations serving Native Hawaiians by supporting the vital programs and services they provide to their communities. Proposals to this grant program may continue, enhance, or expand existing programs and services, or they may launch new ones to address emergent needs and unexpected hardships.

Applications are due June 28, 2021 for award amounts of \$10,000 - \$50,000.

# Available Grants and Funding

#### **American Institute for Conservation**

Foundation for Advancement in Conservation (FAIC) Individual Professional Development Scholarship helps defray professional development costs for Professional Associate or Fellow members of AIC. Proposed projects may include seminars, courses, research, or other continuing education endeavors. This award is not available to support expenses for attending the AIC Annual Meeting, with the exception of workshop fees.

Application deadline September 15th with a maximum award of \$1,000.

Workshop Development Grant for the purpose of developing continuing education workshops for conservation professionals and other interested individuals. Funds may be used to help defray costs for instructor fees, instructor travel, materials, and supplies needed for the workshop. Workshops may focus on specific materials, specialties or processes useful to the conservation profession at large; may adapt knowledge from allied professions that is pertinent to a general conservation audience; may advance the field of conservation; and/or may focus on skills useful to conservators as a refresher course.

Application deadline September 15th with a maximum award of \$1,000.

Community Partnership Project Grant pairs conservators with collections that need care. A group of conservators typically volunteer 1-2 days of their time to work with curators, archivists, or collections managers to provide basic care and rehousing for specific collections. A successful Community Partnership Project includes local and regional publicity such as television, newspaper, and magazine coverage to publicize the need for collections care and preservation. All publicity and news releases must recognize FAIC's financial support.

Application deadline September 15th with maximum award of \$1,000.

<u>Lecture Grant</u> provides funds toward the presentation of public lectures to help advance public awareness of the conservation of historic and artistic works. Lectures advancing public awareness of historic preservation or other preservation topics may be considered but preference will be given to lectures that incorporate awareness of conservation programs and projects. Application deadline September 15th with maximum award of \$500.

#### **Texas Historical Commission, Museum Services**
