Available Grants and Funding

American Alliance of Museums

Museum Assessment Program offers five assessments: Organizational, Collections Stewardship, Education & Interpretation, Community & Audience Engagement, and Board Leadership. Through a Cooperative Agreement with the Institute of Museum and Library Services, AAM is able to offer assessments at a low cost to museum that meet the eligibility criteria.

Application deadline is February 1, 2021 with varying participation fees depending on institution size.

National Endowment for the Humanities

Preservation Assistance Grants for Smaller Institutions help small and mid-sized institutions to improve their ability to preserve and care for their significant humanities collections. Applicants must draw on the knowledge of consultants whose preservation skills and experience are related to the types of collections and the nature of the activities on which their projects focus.

Application deadline January 14, 2021 with maximum award amount of \$10,000

National Digital Newspaper Program is a partnership between the NEH and the Library of Congress to create a national digital resource of historically significant newspapers published between 1690 and 1963, from all the states and U.S. territories. This searchable database will be permanently maintained at the Library of Congress and will be freely accessible online.

Application deadline January 14, 2021 with a maximum award amount of \$325,000

Sustaining Cultural Heritage Collections program helps cultural institutions meet the complex challenge of preserving large and diverse holdings of humanities materials for future generations by supporting sustainable conservation measures that mitigate deterioration, prolong the useful life of collections, and support institutional resilience: the ability to anticipate and respond to disasters resulting from natural or human activity.

Application deadline January 14, 2021 with a maximum award amount of \$50,000 (Planning) and \$350,000 (Implementation).

<u>Digital Humanities Advancement Grants</u> supports innovative, experimental, and/or computationally challenging digital projects at different stages of the lifecycles, from early start-up phases through implementation and sustainability. The program also supports scholarship that examines the history, criticism, and philosophy of digital culture or technology and its impact on society. Proposals are welcome in any area of the humanities from organizations of all types and sizes.

Application deadline January 15, 2021 with a maximum award amounts of: Level I - \$50,00; Level II -\$100,00; Level III - \$325,000

Infrastructure and Capacity Building Challenge Grants strengthen the institutional base of the humanities by enabling infrastructure development and capacity building. Awards aim to help institutions secure long-term support for their core activities and expand efforts to preserve and create access to outstanding humanities materials. The program funds two distinct types of projects: Capital Projects and Digital Infrastructure.

Application available March 18, 2021 with application deadline May 18, 2021 and a maximum award amount of \$750.000



Available Grants and Funding

National Endowment for the Humanities, continued

Humanities Collections and Reference Resources supports projects that provide an essential underpinning of scholarship, education, and public programming in the humanities. This program strengthens efforts to extend the life of cultural materials and make their intellectual content widely accessible, often through the use of digital technology. Awards are also made to create various reference resources that facilitate use of cultural materials, from works the provide basic information quickly to tools that synthesize and codify knowledge of a subject for in-depth investigation Application available May 15, 2021 with application deadline of July 15, 2021. Maximum award amount for Implementation projects \$350,000 and \$50,000 for Foundations projects.

Texas Historical Commission, Museum Services

THC's Museum Services Program has a Grant Funding and Assistance for History Museums PDF that lists a variety of grants available for history museums. They also list other grant funding opportunities on their website.
