That important work is wrapping up and I want to thank all of you who responded to our surveys and shared your thoughts and concerns at our focus groups.

Although this research is nearly complete, you still have an opportunity to shape our 2021 programming by responding to our technology needs assessment that will be open until the end of the year. We are currently analyzing that data to understand the specific obstacles that Texas museums are facing during these times. We will then report back out to our community as we state these challenges and then move towards developing professional development content that we can deliver online. In the meantime, I want to highlight some of our upcoming programs.

On December 9th, TAM is pleased to offer our next online program, Managing Museum Risks During a Pandemic. In that webinar, Joy Simpson, Higginbotham's museum and fine arts expert, will discuss how risks from pandemics are addressed in the insurance policies typically held by museums. She will be joined by TAM member, Jessica Bermes, who serves as Membership Associate & Modern Contemporaries Liaison at the Modern Art Museum of Fort Worth. Bermes will give some practical guidance by addressing how they applied risk management best practices to keep members connected & engaged with the museum through the pandemic.

And save the date for February 3rd, when a team from Hollaback!, an organization devoted to ending harassment in all its forms, presents Conflict De-escalation and Bystander Intervention. If you or your team interfaces with the public, chances are you have faced moments of escalation and not been entirely sure what to do. In this 90 minute online workshop, you will learn Hollaback!'s Observe-Breathe-Connect methodology, which will teach you how to identify

potential conflict before it escalates using their “pyramid of escalation” and how to assess whether de-escalation is the right action. Both these webinars are free for members and low cost for non-members. Make sure to sign up today!

And finally, in April, we will be returning to San Antonio or your home office for TAM 2021: Roots and Reckoning: Museums Respond and Redefine. Learn more about how we are structuring this decentralized hybrid Annual Meeting on TAM’s website. Social distanced programming will be held across the city.
