Second Annual UNLA Awards Reception



The Utah Nursery & Landscape Association is excited to announce the Second Annual UNLA Awards Reception, scheduled for January 6 during the 2025 Utah Green Conference. This event will celebrate members who have made significant contributions to the industry or achieved notable success in their projects.

The success of this awards program relies on our members' participation. Nominations are open until October 11, and we encourage all members to nominate their deserving colleagues across various award categories, which are detailed below.

Awards will be determined either by the number of nominations received or by a vote from the UNLA board based on established criteria.

General Awards Categories

- **Distinguished Contribution Award.** The purpose of the UNLA's Distinguished Contribution Award is to recognize and celebrate outstanding contributions to the nursery and landscape industries. Any UNLA member who has significantly contributed to any aspects of the Utah Green Industry, is eligible. We envision this award to be akin to a UNLA "hall of fame" where we honor the many long-standing, well-known contributors to the industry who have influenced so many of us over the years. This award will be chosen based on the person who receives the most nominations.
- **Public Service Award** (Municipalities, Water Districts and Educators). The purpose of the UNLA's Public Service Award is to honor a career public servant who has made significant contributions by implementing or enacting policies that promote professional development, innovation, and best practices for their organization. This award is likewise intended to recognize those people who have been career public servants and who have offered that service in meaningful, productive, and impactful ways. This award will be chosen based on the person who receives the most nominations.
- **Women in the Green Industry Award.** The purpose of the UNLA Women in the Green Industry Award is to recognize a woman who has made significant and impactful contributions and/or who has demonstrated achievement, growth, and success in the Utah green industry. The green industry has been, and in many ways still is, a male-dominated industry, but we have many wonderful women who are working to bring positive changes on that front and are making fantastic contributions in the process. The UNLA hopes to foster that development and wants to recognize women who have been and are making the industry better. This award will be chosen based on the person who receives the most nominations.
- **Outstanding Merit Award.** The Outstanding Award of Merit seeks to honor those people who have unselfishly given their time, resources, or talents to serve the association. This award is intended to recognize individual members who have served UNLA in an outstanding manner. Eligibility includes any member of any UNLA membership classification or representative of a member firm of the UNLA. The recipient of this award will be decided by the UNLA Executive Board.

Project Awards Categories

(Eligibility Requirements: The landscape awards are open to UNLA members only. UNLA members may submit projects that are completed in Utah.)

- **Commercial Landscape Installation Excellence Award.** This award recognizes companies for their accomplishments and outstanding work on a recent commercial

Understanding the Legislative Process: How Bills Become Law in Utah

The process of turning an idea into law is both intricate and fascinating. In Utah, this journey begins in the Utah Legislature, a bicameral body consisting of the Senate and the House of Representatives. Here's a breakdown of how a bill navigates through the legislative labyrinth to become law.

1. Introduction of a Bill

Every legislative session begins with the introduction of bills. A bill can be proposed by a legislator, a committee, or even by the governor. In the Utah House of Representatives, a bill is assigned a number and read for the first time. The bill's sponsor, usually the legislator who proposed it, presents it to the House. In the Senate, the process is similar, starting with the bill being introduced and assigned a number.

2. Committee Review

Once introduced, a bill is assigned to a relevant committee. This committee plays a crucial role, as it reviews the bill in detail. During committee meetings, the sponsor explains the bill, and experts or interested parties may testify. The committee members debate the merits and drawbacks of the bill, suggesting amendments if needed. After thorough discussion, the committee votes on whether to pass the bill out of committee.

3. Floor Debate

If a bill passes out of committee, it moves to the floor of the chamber where it was introduced. Here, all members of the chamber debate its merits. The bill undergoes additional scrutiny and can be amended further. Members discuss the implications, benefits, and potential issues. After debate, the bill is put to a vote. If it passes, it moves to the other chamber (House or Senate) for consideration.

4. Consideration in the Other Chamber

The second chamber follows a similar process. The bill is assigned to a committee, debated, and possibly amended. If the second chamber passes the bill with amendments, the bill returns to the original chamber for review of those changes. Both chambers must agree on the final text of the bill.

5. Final Approval and Governor's Review

Once both chambers agree on the final version, the bill is sent to the governor. The governor has several options:

- Sign the Bill: The governor signs the bill, making it law.



- Veto the Bill: The governor rejects the bill. The legislature can override the veto with a two-thirds majority vote in both chambers.
- Allow the Bill to Become Law Without a Signature: If the governor does not act on the bill within a certain timeframe, it automatically becomes law.

6. Implementation

After a bill is signed into law or allowed to become law without a signature, it is assigned a specific effective date. Some laws go into effect immediately, while others may have a delayed start to allow for necessary preparations.

This legislative process ensures that each bill is thoroughly examined and debated before becoming law. The Utah Legislature's methodical approach reflects a commitment to thoughtful governance and the democratic process. As citizens, understanding this process empowers us to participate more effectively in shaping the laws that govern our state.

One new bill that may be of importance to UNLA members was signed into law this year. House Bill 11 – "Water Efficient Landscaping Requirements" states that all Local Entities (Counties, Cities, Towns), School Districts, and Highway Authorities may not use overhead irrigation in new construction design for any landscape area except those designated as "Active Recreation Areas". This requirement has been in effect as of May 1st, 2024. The entire contents of the bill can be found here: <https://le.utah.gov/~2024/bills/static/HB0011.html>

7. Learn, Participate, and Engage

There are many things we, as members of the UNLA, can do to take an active part in future legislation in the State of Utah. Find out who your local representatives are and reach out to them via email, phone, or social media to express your views on issues or propose new ideas. Attend town hall meetings or public forums where you can speak directly with your representatives. Legislative committees often hold public hearings to discuss bills. Attending these meetings can provide insights into the bill's progress and give you the opportunity to testify or submit written comments. If you have expertise or a strong opinion on a bill, you can request to testify at a committee hearing. Your testimony can influence the committee's recommendation on the bill.

The UNLA Advocacy Committee is dedicated to keeping our members informed on impactful new bills and legislation coming up in the 2025 General Session starting in January. Please watch for more information coming in future Trunkline articles as it becomes available.
