- **A) “Leading Without a Badge: Maximizing the Value of Professional Staff in Modern Policing”**
— Ben Haiman, Executive Director, Center for Public Safety & Justice, University of Virginia — Roanoke Ballroom

Today's public safety organizations rely on far more than sworn personnel to achieve their mission. Professional staff members serve as strategists, analysts, communicators, technologists, attorneys, financial managers, human resource professionals, researchers, trainers, project managers, and executive advisors. They often provide the specialized expertise that enables agencies to address increasingly complex operational, technological, legal, and organizational challenges.

Yet many agencies continue to underutilize these critical team members, limiting their impact and missing opportunities to improve effectiveness, efficiency, innovation, and organizational resilience.

Drawing on lessons learned from leading one of the nation's largest civilian public safety workforces and from the work of the National Association of Professional Staff in Public Safety (NAPSPS), this session explores how law enforcement leaders can better recruit, develop, integrate, and leverage professional staff talent. Participants will examine common barriers that prevent professional staff from contributing at their highest level and learn practical strategies for creating a culture where sworn and professional staff work collaboratively toward shared organizational goals.

Attendees will leave with actionable ideas to strengthen workforce capacity, improve organizational performance, enhance succession planning, and maximize the return on their agency's investment in professional staff talent.

- **B) “Leading the Fight: Building a Department-Wide Response to Human Trafficking in Virginia”**— Lindsey Lane, Director-U.S. Programs & Nathan Whiteman, Law Enforcement Advisor, Human Trafficking Institute — Washington Lecture Hall

Human trafficking is not limited to Virginia's urban corridors. It is happening in small towns, rural communities, and suburban jurisdictions across the Commonwealth, and the recent expansion of casino gaming has introduced new venues and new vulnerabilities that law enforcement leaders cannot afford to overlook. This session takes an honest look at the scope and scale of human trafficking in Virginia, using real case studies to illustrate how trafficking presents across a range of typologies and jurisdictions. Chiefs and command staff will leave with a clearer picture of what trafficking looks like in their own backyard, receive practical strategies for improving their department's ability to recognize and respond including exploring technology and tools used to identify and investigate trafficking, and receive direct access to free materials, training and ongoing support resources available to their agencies through the Human Trafficking Institute.

- 1:00 – 2:00 p.m. — **“AI Investigative Methodology for Criminal Investigations”** — Morgan Wright, CEO & Founder, National Center for Open & Unsolved Cases; Det. (Ret) Johnny Capocelli, Chesterfield Co. Police Dept. (1 hr. Career Development)

Your investigators are outnumbered. Digital evidence, tips, and open cases grow faster than any agency can staff against them. Artificial intelligence is supposed to close that gap — but most departments are handed tools, not methods, and a tool without a method is just a faster way to make the same mistakes.

This session introduces the AI Investigative Methodology Center (AIM Center), a division of the National Center for Open and Unsolved Cases (NCOUC). The AIM Center's work rests on a simple premise: the value of AI in an investigation is determined not by the model, but by the question you put to it. We have built structured, repeatable prompt frameworks that turn general-purpose AI into a disciplined investigative partner — one that surfaces overlooked connections, stress-tests assumptions, and accelerates review without replacing the investigator's judgment.

Designed for chiefs and executives, this session moves past the hype to operational reality: what structured AI methodology looks like in casework, where it creates leverage, and where it must never be trusted. You will leave understanding how to deploy AI as a force multiplier your agency can actually govern.

- 3:30 – 4:30 p.m. — **“How Barnes v. Felix Impacts Use of Force Training, Reporting, Investigation, and Litigation”** — Chief Timothy J. Longo, Sr., Esq., AVP for Safety & Security, University of Virginia Police Division (**1 hr. Legal**)
In 2016 in Harris County, Texas, Officer Roberto Felix Jr. initiated a traffic stop of Ashtian Barnes for unpaid tolls. After questioning Barnes, smelling marijuana, and telling him to stop digging around in the car, with the driver’s door open, Officer Felix told Barnes to step out of the vehicle. Instead, Barnes started the car and began to drive away. Officer Felix jumped onto the doorsill and, now riding on the outside of the accelerating vehicle, shouted twice for Barnes not to move before firing two shots into the car, killing Barnes.
Barnes’ family sued, alleging the use of deadly force violated his 4th Amendment rights. The District Court granted and the Fifth Circuit Court of Appeals upheld a summary judgment in favor of Officer Felix and Harris County. Applying the “moment of threat” rule used by the 5th Circuit (as well as the 2nd, 4th, and 8th Circuits), the Court found the officer could reasonably have feared for his life, so there was no constitutional violation. This rule limited analysis of the reasonableness of the use of force to the facts occurring in the two seconds where Officer Felix was riding on the doorsill of the car as Barnes accelerated, just before Felix fired his handgun.
In Barnes v. Felix, the U.S. Supreme Court unanimously reversed the 5th Circuit Court, finding the “moment of threat” rule improperly narrows the reasonableness inquiry under the Fourth Amendment.² The Court invoked the well-established rule of Graham v. Connor that Fourth Amendment objective reasonableness must be determined under the totality of the circumstances.³ The Court issued a narrow decision stating, “Most notable here, the ‘totality of the circumstances’ inquiry into a use of force has no time limit.”⁴
The Court sent the case back to the lower court for reconsideration as to reasonableness, considering all the facts, without an artificially limiting time frame. Four justices joined in a concurrence acknowledging the dangers and uncertainties faced by officers during traffic stops, perhaps signaling those justices will continue to give substantial deference to discretionary decisions made by officers in situations that, as noted in the Graham case, are tense, uncertain, and rapidly evolving. The Court also did not address the concept of officer-created danger as it was not argued before the district or circuit court. This decision should not require any changes in policy, but it affirms the importance of documenting all facts preceding a use of force as they may be considered in a later reasonableness analysis.

- **A) “Can Agencies Effectively Manage Fatigue Risk”** — Brett Cowell, Senior Program Manager, National Policing Institute & Dr. Stephen James, Associate Professor, Washington State University — Roanoke Ballroom

Fatigue is a major risk factor for motor vehicle collisions and other negative events, compromising officers’ performance and critical decision-making capacity. Yet, fatigue is a common issue in law enforcement, exacerbated by staffing shortages and increased operational demands. This presentation will identify fatigue-related risks and detail a groundbreaking, first-of-its-kind assessment of a fatigue management program, conducted in partnership with the Delaware State Police. Speakers will discuss the study’s findings and recommendations and describe how other agencies can effectively manage fatigue risk. 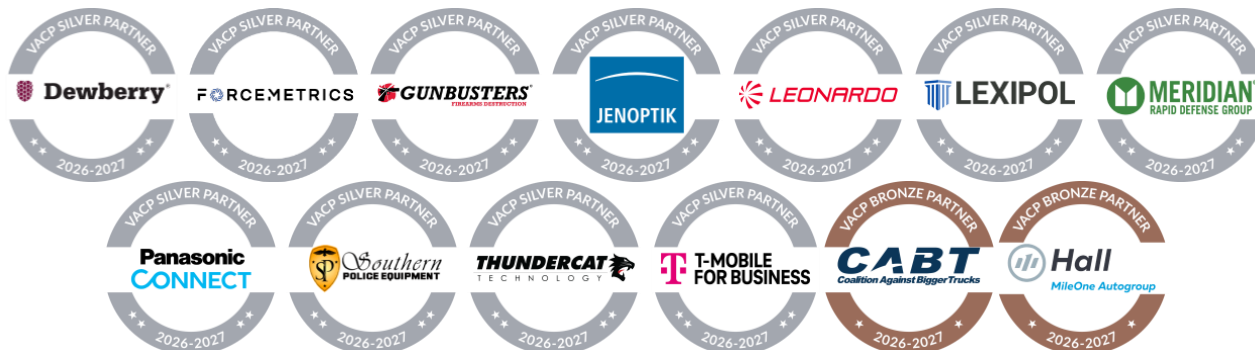

SPEAKER BIOS

Colonel Jeffrey S. Katz, Superintendent, Virginia State Police

Col. Jeffrey S. Katz serves as superintendent of the Virginia State Police, where he leads a statewide law enforcement agency responsible for safeguarding the commonwealth through strategic operations, partnerships and public safety initiatives. He brings more than three decades of experience in law enforcement and public service, including prior service as chief of police in Chesterfield County, Virginia, and Boynton Beach, Florida.

Col. Katz has also served with the Federal Bureau of Investigation, where he was assigned to the Training Division at Quantico. There, he contributed to the development of senior law enforcement leaders. During that time, he created a graduate-level course for the FBI National Academy focused on preparing aspiring chiefs, sheriffs and agency directors. He also served as adjunct faculty with the University of Virginia and supported executive-level instruction in public safety.

His leadership has been associated with nationally recognized efforts in officer safety, traffic safety, and recruitment and retention; throughout these fields, he has held a consistent focus on organizational culture, workforce development and community engagement.

Col. Katz holds a master's degree in business leadership and has completed doctoral coursework in organizational psychology. He is a graduate of the FBI National Academy, the FBI National Executive Institute, the Southern Police Institute's Command Officers Development Course and Harvard Kennedy School's Senior Leaders in State and Local Government program.

General John F. Kelly, USMC (Ret.) & Former White House Chief of Staff

Former White House Chief of Staff (2017-2019); Former U.S. Secretary of Homeland Security; 45-Year Marine Veteran; Former Commander, U.S. Southern Command

Retired Gen. John Kelly is a 45-year Marine veteran who headed the U.S. Southern Command, where he focused on U.S. border security, organized crime, terrorist organizations and drug traffickers in his Latin American region for more than three years. Kelly retired as a four-star general in 2016. He then served as the 5th United States Secretary of Homeland Security in the Trump Administration, where he earned a reputation for being an aggressive enforcer of ethics, established Homeland Security policy, and most importantly, the law. After six months, he was selected to serve as White House Chief of Staff.

Since leaving the White House, General Kelly regularly lectures and conducts focused seminars on ethical and moral leadership, team building, and decision making. He has also presented at various programs regarding the state of American society and democracy, what the future may look like, and how Americans can stop erosion by electing the right kind of leaders from the city council level all the way up to president of the United States.

Ben Haiman, Executive Director, Center for Public Safety & Justice, University of Virginia

Marvin "Ben" Haiman is Executive Director of the University of Virginia's Center for Public Safety and Justice and an Assistant Professor of Public Safety. A former Chief of Staff for Washington, D.C.'s Metropolitan Police Department, he brings extensive experience in public safety leadership, organizational transformation, workforce development, and innovation. He is also the founding Executive Director of the National Association of Professional Staff in Public Safety.

Haiman graduated from Johns Hopkins University with a master's degree in management through the Police Executive Leadership Program. He earned his undergraduate degree in mathematics from the University of Iowa and received designation as a Certified Public Management Program through George Washington University, as well as certification in Strategic Project Management. Haiman is also a graduate of the Naval Postgraduate School Center for Homeland Defense and Security's Executive Leadership Program. He received recognition by the International Association of Chiefs of Police in 2020 as a 40 under 40 recipient and the prestigious Gary P. Hayes Award by the Police Executive Research Forum. Haiman graduated from the Metropolitan Police Academy and continues his police service as a reserve police officer with the Metropolitan Police Department. Haiman resides with his family in Washington, D.C."

Lindsey Lane, Director of U.S. Programs, Human Trafficking Institute

As the Director of U.S. Programs at the Human Trafficking Institute, Lindsey leads all domestic initiatives including the authorship of HTI's annual Federal Human Trafficking Report, the Douglass Fellowship program, and HTI's domestic training programs in Virginia and Texas.

Lindsey brings extensive experience as a former human trafficking and major crimes prosecutor, having served in both North Carolina as a human trafficking prosecutor, and state and Special Assistant United States Attorney in the Eastern District of Tennessee.

A recognized expert and national presenter, Lindsey uses her extensive anti-trafficking experience to train law enforcement, prosecutors, judges, and service providers across the U.S. and abroad. She is a Certified Training-of-the-Trainer, a POST-certified law enforcement trainer, and faculty member at the National Judicial College.

Nathan Whiteman, Law Enforcement Advisor, Human Trafficking Institute

As Law Enforcement Advisor for HTI, Nathan delivers strategic training on investigative and prosecutorial best practices for human trafficking. Nathan spent twenty years as an FBI Special Agent in Atlanta as team leader for the Child Abduction Rapid Deployment (CARD) team and profiler in the Behavioral Analysis Unit (BAU) at Quantico. He investigated hundreds of trafficking cases and worked with agencies nationwide. From 2007 to 2019, Nathan led the Metro Atlanta Child Exploitation (MATCH) Task Force, the FBI's largest child exploitation and human trafficking task force, building interagency partnerships and mentoring officers. His profiling work spanned human trafficking, serial crimes, missing children, and child abuse. Nathan holds a B.S. in Spanish Education and an M.A. in Spanish from Millersville University of Pennsylvania.

Morgan Wright, CEO & Founder, National Center for Open & Unsolved Cases

Morgan Wright is an investigative intelligence expert, former state trooper and homicide detective, and national security advisor applying modern intelligence, behavioral analysis, and AI to reveal the truth buried inside open and unsolved cases. He has testified before the United States Congress on advanced technology and has trained investigators at the NSA, FBI, and CIA.

Morgan is the creator of the Department of Justice Law Enforcement Information Sharing Program (now "NDEX") and is a former senior advisor to the U.S. State Department's Antiterrorism Assistance Program, a former technical advisor for America's Most Wanted, and was the senior law enforcement advisor for 2012 Republican National Convention.

Chief Timothy J. Longo, Sr., Associate Vice President for Safety & Security, University of Virginia

Timothy J. Longo Sr. was appointed the University of Virginia's associate vice president for safety and security and chief of police in November 2019. In this capacity, Longo oversees the UVA Police Department, the department of Emergency Management, Clery Act compliance and the Office of Youth Protection, threat assessment, and safety and security systems and technology. He brings more than 40 years of experience in law enforcement leadership and higher education to his role.

Longo joined the Baltimore Police Department in June 1981, eventually rising to position of police colonel/chief of technical services. While there, he earned his Bachelor of Science from Towson University in 1985 and his Juris Doctorate from the University of Baltimore in 1993. He retired from the Baltimore Police Department in March 2000 and went to work briefly as a consultant in D.C. for a firm that focused on law enforcement matters. In 2001, he was appointed as chief of police in Charlottesville.

During his 15-year tenure with the Charlottesville Police Department, Longo was responsible for providing leadership over several high-profile investigations that impacted the University of Virginia community: the murder of student athlete Yeardley Love, the disappearance and murder of second-year student Hannah Graham, and the investigation into allegations of sexual assault stemming from a 2014 article in Rolling Stone magazine. He retired from Charlottesville Police Department in 2016.

Later in 2016, Longo joined the faculty of the University of Virginia's School of Continuing and Professional Studies to create a master's degree in public safety that addresses such issues as the challenges of 21st-century policing and the evolving role of law enforcement in serving the communities they protect. He also serves as an adjunct faculty member at UVA's Law School, where he teaches Police Use of Force, and guest lectures in a host

of other programs related to the criminal justice system.

In addition to his primary law enforcement and educational endeavors, Longo has served as part of a team of independent monitors appointed to conduct police department oversight on behalf of the federal courts in three cities across America. In addition to these responsibilities, he has served as a police practice expert on behalf of both plaintiffs and defendants in a variety of legal matters in state and federal courts pertaining to law enforcement and municipal policy and practice.

Mr. Cory McGookin, Executive Director, Virginia Association of Chiefs of Police

Cory McGookin serves as Executive Director of the Virginia Association of Chiefs of Police and the Virginia Association of Campus Law Enforcement Administrators, where he leads statewide initiatives focused on law enforcement leadership development, professional education, organizational effectiveness and public safety collaboration. VACP represents more than 500 law enforcement executives, administrators, and public safety leaders across the Commonwealth of Virginia.
