

MEASURES OF SUCCESS – 2024

VTCA will never waiver in its commitment to its core purpose – serving as your advocate. VTCA is respected as the leading voice for Virginia's transportation construction, engineering, and aggregates industries. Protecting Your Investment is our top priority.

• VTCA's strategic goal has been growing VDOT's Six-Year Funding Plan. We helped DOUBLE program funding from \$10.6 billion to \$19.6 Billion = Adding 1,500 MORE VA projects.

Advocacy with Agency Partners

- VTCA is aggressively fighting local efforts to pursue mandated Project Labor Agreements. https://virginians4fairness.org/.
- VTCA engaged VDOT and advocated for streamlining forms, realistic submission deadlines, and clarifying VDOT policy resulting from new Federal DBE requirements.
- VTCA has been **updating the claims manual** and **introducing new steps to improve the handling of change management**, emphasizing resolution before transitioning to a claim.
- VTCA initiated a meeting with VDOT and the Virginia State Police to explore ways to *improve work zone safety*, resulting in pilot testing of photo speed enforcement and enhanced training for police.
- VTCA addressed persistent industry concerns, questions, and cost risks associated with VDOT implementing DEQ's new turbidity monitoring requirements.
- VTCA's Engineering Consultants successfully established a **pilot initiative of Turnkey projects**, enabling firms to manage select projects on behalf of VDOT, freeing up VDOT staff to work on other tasks.
- VTCA **defeated five localities' zoning efforts to restrict Aggregate production** providing awareness on why local zoning ordinances need to allow mining production.
- VTCA successfully defeated legislation that would have required public notification of mineral exploration activities.
- Completed, published and commenced distribution of the "The Economic Contribution of Construction Aggregate and Industrial Mining in Virginia" report and developed a supporting video aimed for social media outlets.
