
Trends and Results

Registering for MCS Class

- Must have a Workforce student profile
- DO NOT create a duplicate profile update information in existing profile if any information has changed
- When creating a student profile, use the student's/employee's information
 - Name BE CONSISTENT
 - Email, phone number, DOB, SSN





Paying for MCS Class

- Payment by eCheck no fee
- Payment by credit card there is a fee charged by the vendor
 - If needed, request a copy of the receipt at the end of the payment process
- Company payment company can be set up as a 3rd party payer





FastForward Grant

- For courses that are in the FastForward program, the grant can only be used one time per credential per person
- The Virginia domicile requirement is based on the student (not the employer)

Receiving Credit/Credential

CLASSES IN CANVAS

Class available and login information sent within 24-48 hours after purchase

VDOTU

- Certifications are located in VDOTU, so students must have an account in VDOTU
- Must have a grade release form on file for grade transfer
- Grades are sent to VDOT, and VDOT uploads the grades into VDOTU

*It is strongly recommended that each company have a go-to person to help their employees with registration, Canvas, technology issues, etc.




Virtual Proficiency Testing

Before


- CCWA emails necessary forms, charts, and graphs to the student that need to be printed out and used during the tests.
- Virtual proficiencies often take longer than in-person.
- Student need access to all necessary equipment at their site.
- CCWA provides a Zoom link to student at least 3 days in advance of testing.





During

- Camera #1 (Cell phone) should show student's entire work area and should cover enough area for the proctor to assess the student's proficiency with the equipment
- Camera #2 (Computer) should show student/used for giving student information during exam
- No other people in the room, no extra papers, check ID
- There is a script for prompting the student with various questions






After
