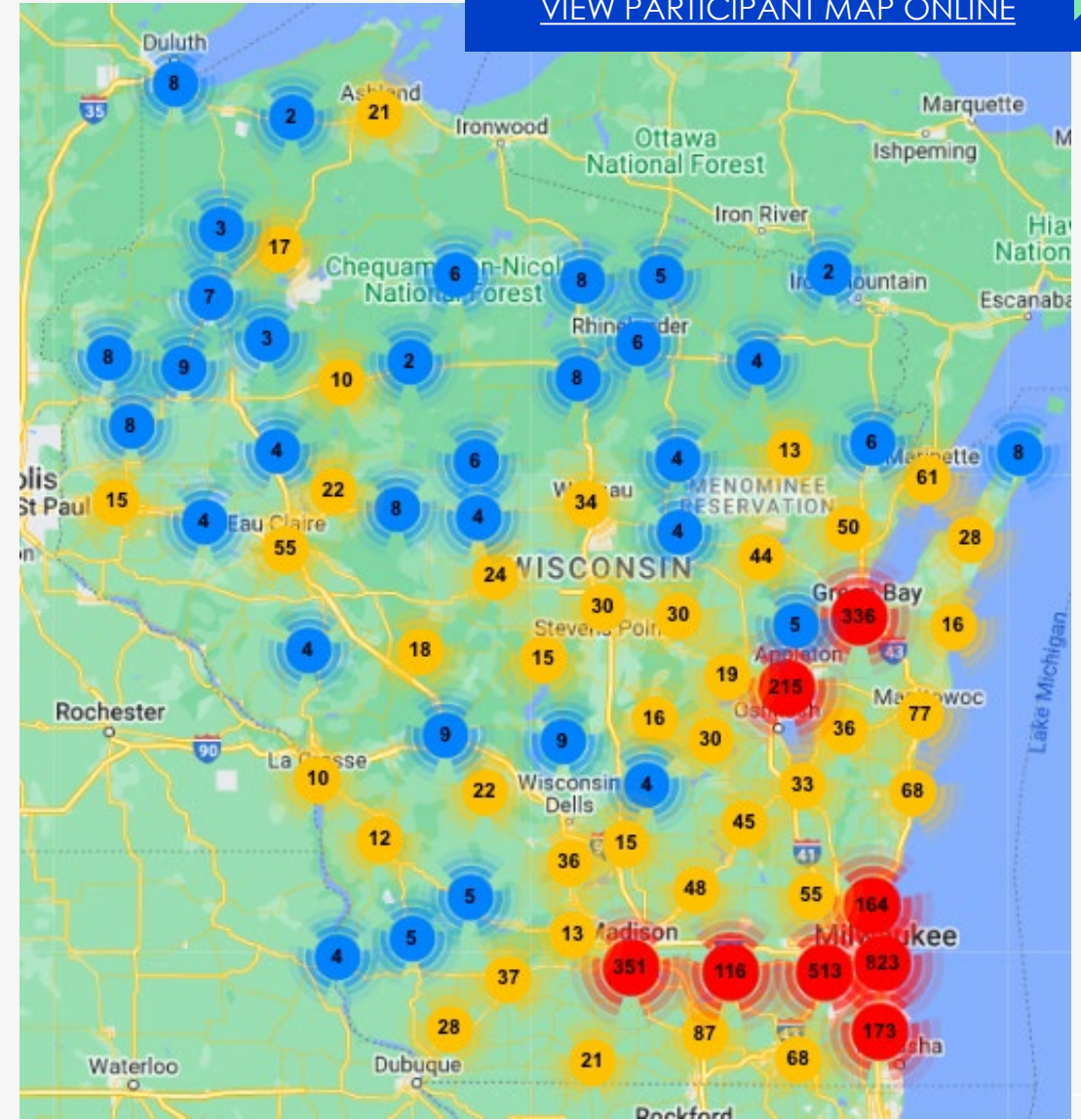

Any connection is possible – it only requires authorization from your organization to your EHR

How does Health Information Exchange benefit MCOs?

Enhanced Transparency:

- Clear communication between healthcare providers
- Accessible patient information
- Real-time updates on treatment plans and progress
- Greater visibility into care decisions, billing, and scheduling

Continuity of Care:

- Seamless transitions between healthcare providers
- Consistent care across multiple settings
- Better coordination among specialists, primary care, and support staff
- Patient history and treatment details easily shared among providers

Easier Accessibility than Calling Facility:

- 24/7 access to resident information via online portals
- Direct messaging with providers for quick questions or updates

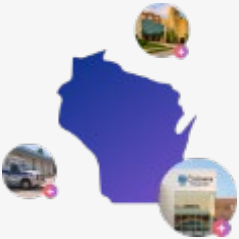

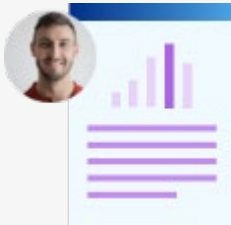

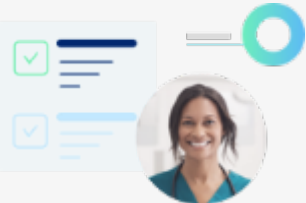

Possibilities Using Health Information Exchange (HIE)

Improve Admissions & Continuity of Care

- 80% of hospitals in the network
- Inform facility decision-making based on real-time data
- Facility data available through WISHIN to Provider orgs
- Ditch the Fax!

Notifications to Inform Providers

- Avoid preventable readmissions
- Visibility to planned or unplanned transitions
- Care Team information in WISHIN to coordinate care
- Notifications through partner – Bamboo Health

Workflow Enhancements

- Direct access to WISHIN from EHR or from Bamboo Health
- Automate exchange of data... nurses/coordinators don't need to fax or request
- Enhance preferred facility position

Benefits of Implementation

- Pre-Admission assessment:
 - Ensures resident is at appropriate setting based on level of care needed
 - Reducing time to complete admission
- Streamline hospital admissions/ readmissions after hospital stay
- Not limited to one provider's H&P - ability to access all records
- Improved patient safety and security of data following all HIPAA guidelines
- Increased efficiency to ease transition to higher level of care/ discharge
- EMS transparency - no more printing off paperwork as the resident is being wheeled out the front door!

Soft Cost of Implementation

- Operational Costs for Facilities: Access data quicker and easier in real-time, saving work hours
- Operational Costs for Hospitals and Providers: Reduces paperwork, faxes, phone calls, and manual processes for answering questions
- Increased Efficiency: Reduction in medical errors from transferring data
