


Residential Care Apartment Complex (RCAC)








Assisted Living vs. LTC Capacity


Trend in Capacity for Residents





Ownership by Percentage: All AL Facilities












Assisted Living Complaints Calendar Year (CY) 2023




Assisted Living Complaints Received





Complaints Received CY 2023




Source of Complaint CY 2023










Percentage of Facilities with Complaints Submitted




Percentage of Substantiated Complaint Investigations







Assisted Living Self-Reports Calendar Year 2023










Assisted Living Enforcement CY 2023





Assisted Living Facilities with No New Admission Orders








Number of Facilities with Enforcement Sanctions by Type





