### **CDC Expands Definition of "Close Contact"**

The Centers for Disease Control and Prevention Wednesday revised its definition of <u>a "close contact"</u> to include anyone within six feet of a person infected with COVID-19 for a total of 15 minutes or more within a 24-hour period, as opposed to 15 consecutive minutes.

### Stimulus Negotiations Continue, While Senate Bill Fails and Hopes Fade for Pre-Election Approval

House Speaker Nancy Pelosi (D-CA) and U.S. Department of the Treasury Secretary Steven Mnuchin say they are <u>on track</u> to reach an agreement over a coronavirus stimulus package by the end of this week, though hopes are fading for Congressional approval prior to Election Day.

While the White House is messaging interest in a package totaling even<u>more than</u> <u>the \$2 trillion proposed</u> by House Democrats, Senate Republican leaders are <u>indicating opposition</u>.

A <u>simpler bill</u> from Senate Republicans, designed to offer business liability protection, reauthorize the Paycheck Protection Program and offer a \$300-per-week unemployment enhancer, was rejected Wednesday on party lines.

## **CFAP Round 2 Payments Now Total \$6.1 Billion**

The U.S. Department of Agriculture this week reports it has<u>distributed \$6.1 billion</u> in direct relief payments to farmers via the second round of its Coronavirus Food Assistance Program, including \$625 million to dairy farmers.

### WDATCP Asks for Industry Partnership to Maintain Inspection Schedules

The Wisconsin Department of Agriculture, Trade and Consumer Protection (WDATCP) is calling on the state's dairy manufacturers and processors to partner with them to maintain timely inspection schedules, as the pandemic continues.

WDATCP has <u>sent letters</u> to businesses regulated and inspected by its Food and Recreational Safety Division - including other food processors and grocers, following the quarantine of inspectors who had been in contact with COVID-19-positive individuals during recent facility visits. Letters ask that plant staff wear face masks and observe social distancing guidelines while inspectors are present.

### ACLU Files Open Records Request for Information on Wisconsin Food Processing Facility Outbreaks

The American Civil Liberties Union (ACLU) of Wisconsin this week filed an<u>open</u> <u>records request</u> with the Wisconsin Department of Health Services for information regarding response to and preparedness for COVID-19 outbreaks in the state's food processing facilities. WCMA will keep members informed of state officials' response.
