WCMA Publicly Pushes for USDA Commodity Purchase, Direct Aid to Farmers

As noted in yesterday's bulletin, some farmers in Wisconsin have been asked to dispose of their milk. WCMA has joined with leading dairy organizations to <u>call on the U.S. Department of Agriculture</u> for direct farmer aid and a massive purchase of dairy commodities, as enabled by the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

Today, WCMA joined with Dairy Business Association and Edge Dairy Farmer Cooperative in broad outreach to media, including a call with more than 30 reporters from national and regional outlets. Here's a look at the first stories published covering our push for USDA action.

Pocan Advocates for Dairy with USDA

Congressman Mark Pocan (D-WI) today <u>sent a letter</u> to USDA, urging dairy product purchases and a reopening of the Dairy Margin Coverage program. WCMA thanks Rep. Pocan for his quick response and advocacy, and is working with other members of Congress to urge USDA action.

Payroll Protection Program Loan Application Available Tomorrow

Many WCMA members will want to participate in the Paycheck Protection Program, authorized by the CARES Act, which provides SBA loans of up to \$10 million through June 2020. SBA will **forgive loans** if all employees are kept on the payroll and money is used for payroll, rent, mortgage interest, or utilities. <u>Complete details</u> are available here.

You are urged to contact your lender immediately about this program, and note that the loan application will go live tomorrow (Friday, April 3).

Apply Now for Economic Injury Disaster Loans

<u>Streamlined application forms</u> for Economic Injury Disaster Loans (EIDL) & Grants are <u>available now</u>.

Please note, all qualifying businesses may receive a \$10,000 cash advance within three days of applying for up to \$2 million of an EIDL. The advance does not need to be repaid, and may be used for payroll, to pay for sick leave, meet increased production costs due to supply chain disruptions, or pay debts, rent, or mortgage payments.

Note that businesses may participate in both the Paycheck Protection Program and EIDLs. Complete details are available here.
