WCMA Continues to Push for Commodity Purchase

<u>WCMA continues to push USDA</u> for direct farmer aid and a massive purchase of dairy commodities, as enabled by the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

We're gaining traction via news reports. WCMA Executive Director John Umhoefer has talked with reporters from *Associated Press*, *Bloomberg*, and *Yahoo Finance* today, among others. Here's a look at coverage from this past weekend.


WCMA Calls for End to Wisconsin Waiting Period for Unemployment Benefits

WCMA is calling on leaders of the Wisconsin State Legislature to immediately vote to end the one week waiting period for much-needed unemployment benefits. Governor Tony Evers first called for this policy change on March 17. Assembly Speaker Robin Vos (R-Rochester) and Senate Majority Leader Scott Fitzgerald (R-Juneau) have signaled support for this proposal, but the state Assembly and Senate have not met to pass this crucial policy change in a time of deep economic uncertainty for Wisconsin businesses.

WCMA Executive Director John Umhoefer has issued this statement: "Wisconsin workers faced with the sudden loss of their jobs and income, due to the coronavirus disruptions, deserve the assurance of immediate relief, not a week of waiting. Our lawmakers have the power to help displaced workers in this moment of crisis, and we call on them to take action now."

WDNR Launches Environmental Compliance Site

WCMA has been working with the Wisconsin Department of Natural Resources (WDNR) on the development of guidance for dairy processors should coronavirus trigger milk disposal from the plant (as opposed to the farm). While this work continues, WDNR has launched compliance website featuring the U.S. Environmental Protection Agency's temporary guidance on noncompliance, and a step-by-step process for working on necessary flexibility.

Evers Orders April 7 Election Postponed to June

This afternoon, Wisconsin Governor Tony <u>Evers postponed tomorrow's statewide</u> <u>election</u> until June 9 after Republicans who control the Legislature declined to take action over the weekend to eliminate in-person voting. All ballots already cast (absentee) will remain valid.

State Republicans immediately announced they would go to the Wisconsin Supreme Court to challenge Evers' order.

WDATCP Calls on Public to "Be There" for Farmers

Wisconsin Department of Agriculture, Trade and Consumer Protection Interim Secretary Randy Romanski today issued an op-ed calling on people to "be there" for farmers, urging consumers to shop responsibly, by more Wisconsin dairy products, donate food to those in need, and to show appreciation for the farmers and processors who provide a stable, nutritious food supply.
