USDA Offering \$1 Billion in Rural Business Loans

U.S. Department of Agriculture (USDA) announced on Thursday it will make up to <u>billion in loan guarantees available to rural businesses</u>, with the purpose of helping to meet their working capital needs during the coronavirus pandemic. Via the new Business and Industry Coronavirus Aid, Relief, and Economic Security will provide 90 percent guarantees and extend the maximum term for these working capital loans to ten years.

Complete details on eligibility and how to apply are<u>available now online</u>. The application deadline is June 22, 2020, or until available funds are expended.
