WCMA Applauds Bipartisan Proposal Expanding Capital Access for Wisconsin Dairy Manufacturers

Marklein Bill Offers \$3 Million in Loan Guarantee Authority

In partnership with WCMA, this week Wisconsin State Senator Howard Marklein (R-Spring Green) [proposed legislation to expand capital access](#) for rural cheese manufacturers and processors. Marklein's bill is co-authored by Senator Janet Bewley (D-Mason), Representative Gary Tauchen (R-Bonduel), and Representative Don Vruwink (D-Milton).

The [capital access proposal](#) would launch a pilot program at the Wisconsin Housing and Economic Development Authority (WHEDA). Using existing funds available through the Agribusiness Guarantee Program, \$3 million in loan guarantee authority would support rural development projects, including brick-and-mortar investments, equipment and machinery, marketing and working capital.

The pilot would guarantee up to 25 percent of a loan, or \$750,000, whichever is less. The borrower is required to pay back the entirety of the loan, with the state commitment only coming into play in the event of a default. All borrowers would be subject rigorous vetting to participate in the program.

While this bipartisan proposal will be introduced as stand-alone legislation, WCMA staff is working to see it incorporated in the state budget. We will keep you informed of major developments via this electronic newsletter.

Many thanks go to the members of WCMA's Policy Committee for their work to develop and advocate for this proposal.

WCMA Joins Farm Groups in Support of Dairy Innovation Hub



WCMA has joined with its partners in the farming community in support of the Dairy Innovation Hub. This concept would direct \$7.9 million to UW-Madison, UW-Platteville, and UW-River Falls for dairy research and educational opportunities.

Authored by Wisconsin State Senator Howard Marklein (R-Spring Green) and Representative Travis Tranel (R-Cuba City), the proposal advanced through committee this week and could be included as part of the upcoming state budget.


Third Party Review of CDR Project to Study Cost OVERRUNS

As you may recall, in a recent message to members, WCMA shared the news that vendor quotes for the process piping/equipment bid for the Center for Dairy Research/Babcock Hall Dairy Plant renovation project came in at more than \$10 million over allocated funding.



Now, at the request of industry donors, the Wisconsin Department of Administration and the University of Wisconsin System plan to conduct a third-party peer review of the overall project design and construction sequencing. Wisconsin Governor Tony Evers and University leadership have responded to industry concerns that the Center for Dairy Research continue its important work during construction. This review will inform next steps on the project, including sequencing of various phases and coordination of construction, to minimize risk and identify options to bring this project to completion as soon as possible. Information from this peer review will be shared with donors, including WCMA members.

WCMA staff remains in constant contact with the Center for Dairy Research and UW officials, and the Department of Administration and the Office of Governor Tony Evers to ensure industry interests are represented.



Italy Scraps Asiago Trademark Bid

A consortium of Italian asiago makers has abandoned its bid to register a U.S. trademark for exclusive use of the cheese name, a major victory for the Consortium of Common Food Names and for American makers of the same cheese.
