## Chinese, Mexican Tariffs Take Full Effect



Today, new U.S. tariffs on \$34 billion worth of Chinese goods took effect, triggering retaliatory tariffs of 25 percent on American goods, including all forms of milk, whey, cheese, butter, buttermilk, and yogurt, sold in China.

Yesterday, Mexican tariffs on U.S. products, including cheese, increased to 25 percent. On July 1, Canada announced new 10 percent tariffs on a host of American goods, including yogurt and frozen pizzas, but not specifically naming any other dairy-related products. These tariffs

are a response to President Donald Trump's announcement in May to increase tariffs on imports of certain steel and aluminum products from Canada and Mexico to 25%.

## WCMA Joins Call for Tariff Relief

Last week, WCMA joined dairy manufacturers and dairy producer organizations in an urgent request to the Trump Administration to suspend steel and aluminum tariffs on Mexican products to encourage an end to Mexico's retaliatory tariffs on U.S. cheese.

Mexico is the largest international buyer of U.S. dairy products and Wisconsin's largest market for cheese exports. Nearly \$50 million worth of Wisconsin cheese reached Mexican consumers in 2017 - more than a third of all cheese Wisconsin exported. Read the [full release here](#).

## Farm Bill Differences to be Settled in Conference Committee

On June 28, the U.S. Senate passed its version of the 2018 Farm Bill on a bipartisan vote of 86-11. Sen. Tammy Baldwin (D-WI) voted in favor of the bill and Sen. Ron Johnson (R-WI) voted against it. More information on that split is available [here](#).

Notably, the Senate incorporated Baldwin's [Dairy Business Innovation Act](#) into its version; WCMA has publicly supported this proposal, aimed at supporting research and development to address oversupply issues.

As you may recall, the House has already approved its own separate Farm Bill, meaning that the details of the version which will be sent to President Trump for signing will be determined via Conference Committee. For a look at the negotiations ahead, [check out this news article](#).

The most contentious differences in the two bills relate to the Supplemental Nutrition Assistance Program, crop subsidies, and conservation funding - not dairy-specific policy. Both versions include enhancements to the Dairy Margin Protection Program and extend the Dairy Forward Pricing Program to 2023.

## Members Invited to Dairy Exchange Discussion of Milk MicroFiltration Monday, July 23

WCMA members are invited to join in a discussion of milk microfiltration for cheesemaking and native whey recovery at the July 23 Dairy Exchange at the Wisconsin Department of Agriculture, Trade & Consumer Protection (2811 Agriculture Drive, Madison). The meeting is scheduled to begin at 11:30 a.m.

Wisconsin Secretary Sheila Harsdorf has taken up the challenge of gaining regulatory approval of microfiltration for cheesemaking with the U.S. Food & Drug Administration. The Exchange

program will cover promise of this technology, used in many European nations, and the regulatory hurdles ahead to gain acceptance in the U.S. A WDATCP meeting with FDA, planned for later this summer, will bring together Center for Dairy Research experts, WCMA members and International Dairy Foods Association staff to make the case for this safe and beneficial filtration technology.
