WCMA Advocates for Dairy Industry Investments in Wisconsin State Budget



As Wisconsin lawmakers advance in the state budget-writing process, WCMA is advocating for dairy industry priorities.

In meetings with Joint Finance Committee members last week, WCMA staff lobbied for \$1.6 million in funding for the popular dairy processor grant program at the Wisconsin Department of Agriculture, Trade and Consumer Protection, which is currently funded at just \$200,000 per year.

WCMA is pushing for increased investments in the Wisconsin Initiative for Agricultural Exports; \$7.8 million per year for the Dairy Innovation Hub, supporting industry research and training; and \$20 million for a food security initiative, enabling hunger relief organizations to purchase locally-produced dairy, meat, and vegetables.

Together with other agricultural advocates, WCMA is also lobbying for a \$150 million investment in rural road improvements, as well as investments in rural broadband access and rural workforce development programs.

With key budget committee votes approaching next week, WCMA encourages Wisconsin-based members to



take action now to make their voices heard in support of dairy industry priorities.

WCMA congratulates members Miranda Leis of CROPP Cooperative/Organic Valley and Paul Bauer of Ellsworth Cooperative Creamery, who were reappointed by Governor Tony Evers to six-year terms on the Wisconsin Department of Agriculture, Trade and Consumer Protection (WDATCP) Board last week. Leis currently serves as Senior Director of Dairy Handling and Supply for CROPP Cooperative/Organic Valley, and as Vice Chair of the WDATCP Board. Bauer has served as Ellsworth's CEO since 2008. and was also recently selected to rejoin the WCMA Board of Directors beginning in July.

WCMA Supports Bill to Create Federal Dairy **Nutrition Incentive Program**

WCMA has signed on to support the Dairy Nutrition Incentive Program Act of 2023, introduced in Congress last week by U.S. Senators Amy Klobuchar (D-MN) and Roger Marshall (R-KS). The legislation aims to increase consumption of nutritious milk and dairy products by Supplemental Nutrition Assistance Program (SNAP) participants. The Dairy Nutrition Incentive Program builds on milk incentives authorized in the 2018 Farm Bill by expanding the definition of "qualifying products" to include all milk varieties, as well as cheese, yogurt and other cultured dairy products. WCMA will keep members informed of developments as the legislation progresses.

With the nation's key dairy industry groups united on the need for changes, the process to update make allowances in federal milk marketing orders (FMMOs) continues forward, as regulators seek additional information. 
Participants will also hear the latest in dairy export projections from the U.S. Dairy Export Council, and learn about resources available through Dairy Farmers of Wisconsin, Food


WCMA Golf Outing & Trap Shoot Registration Opens Next Tuesday, May 16

Wisconsin Dairy Exporters Invited to Join Midwest Buyers Mission


The Wisconsin Department of Agriculture, Trade and Consumer Protection (WDATCP) and Food Export Midwest invite Wisconsin dairy manufacturers and processors interested in exporting their products to join a Midwest Buyers Mission, set for July 26 in Madison, Wisconsin.

During the mission, participants will have the opportunity to



meet with international buyers from South America, Asia, Canada, and the Caribbean. The mission will include oneon-one meetings with buyers to gain product feedback, discuss business opportunities, and initiate future sales.

Since the creation of the **Dairy Business Innovation Alliance** in the 2018 Farm Bill, WCMA and the Center for Dairy Research have partnered to administer approximately \$7 million in grants to 88 dairy farms and processors. The Alliance now serves an 11-state region including Illinois, Iowa, Indiana, Kansas, Michigan, Minnesota, Missouri, Nebraska, Ohio, South Dakota, and Wisconsin.

WCMA's newest social media series, DBIA Delivers, highlights the successes of dairy entrepreneurs that have taken their businesses to the next level thanks to DBIA grants.

Next in our weekly #DBIADelivers series is <u>Decatur Dairy</u> and the Decatur Swiss Cheese Co-op. These organizations have a unique partnership in which the farmer cooperative provides milk and the dairy makes the cheese and markets the products. The 56 farms currently in the co-op are eager to expand the amount of milk they supply for cheesemaking. Grant funding from the Dairy Business Innovation Alliance will support expansion of the Decatur Dairy cheese plant, which will result in increased production and provide a strengthened market for the co-op farmers and create opportunities for new farms to join.
