## WCMA Applauds Unanimous State Senate Approval of Bill to Expand Rural Capital Access



On Wednesday, June 5, the Wisconsin State Senate unanimously approved [Senate Bill 219](#), legislation championed by WCMA which expands capital access for rural businesses, including cheese manufacturers and processors.

WCMA thanks Senator Howard Marklein (R-Spring Green) for authoring the legislation and shepherding it through committee to the floor, as well as co-authors Senator Janet Bewley (D-Mason), Representative Gary Tauchen (R-Bonduel), and Representative Don Vruwink (D-Milton).

[Senate Bill 219 would launch a pilot program](#) at the Wisconsin Housing and Economic Development Authority (WHEDA). Using existing funds available through the Agribusiness Guarantee Program, \$3 million in loan guarantee authority would support rural development projects, including brick-and-mortar investments, equipment and machinery, marketing and working capital.

As pictured above, WCMA staff and Paul Scharfman, a WCMA Board Member and President of Specialty Cheese Company of Reeseville, Wisconsin, testified in favor of SB 219 in the Senate Committee on Agriculture, Revenue, and Financial Institutions last week.

## Trump Announces New Tariffs on Products from Mexico, China

Last week, President Donald Trump announced that, beginning June 10, he will impose a five percent tariff on Mexican goods, increasing by five percent each month to a maximum of 25 percent, unless he said, "Mexico substantially stops the illegal inflow of

aliens coming through its territory."

Lawmakers on both sides of the political aisle have warned this action could jeopardize passage of the United States-Mexico-Canada trade agreement, hurting the nation's economy.

Meanwhile, on Thursday, President Trump also threatened China with possible tariffs on "at least" another \$300 billion worth of goods, escalating tensions as negotiations between the two countries continue.

The national unemployment rate dropped in April 2019 to 3.6 percent, the lowest level in 50 years. In Wisconsin, the rate is a new all-time record low of 2.8 percent. While we might cheer those numbers as an economic success, they are also cause for employers' concern.


## WCMA Young Professionals to Tour Agropur Ingredients
