WCMA IS A STRONG VOICE FOR YOU.

With direction from our Board and our active Policy Committee, Association staff have worked toward policy and regulatory changes that will boost the dairy processing industry. Here's a look at our impact in 2019.

AT THE FEDERAL LEVEL...

WCMA advocated for the signing of the United States-Mexico-Canada trade agreement, as well as other trade deals to open markets to dairy processors. We continue to push for Food and Drug Administration enforcement of dairy labeling standards. We successfully lobbied for the inclusion of Wisconsin Senator Tammy Baldwin's Dairy Business Innovation Initiative in the 2018 Farm Bill, and we are partnering with the Center for Dairy Research to apply for federal grants through that program. IN WISCONSIN...



WCMA is working with a bipartisan group of lawmakers to advance legislation that would launch a pilot program at the Wisconsin Housing and Economic Development Authority (WHEDA). Using existing funds available through the Agribusiness Guarantee Program, \$3 million in loan guarantee authority would support rural development projects, including brick-and-mortar investments, equipment and machinery, marketing and working capital.



Members of the WCMA Policy Committee met with WDATCP Secretary Brad Pfaff and Assistant Deputy Secretary Angela James in February 2019, helping secure agency changes that benefit our industry.

WCMA HAS ALSO

- Supported Dairy Innovation Hub proposal to direct funding to dairy training and research programs at University of Wisconsin schools (AB 207/SB 186)
- Advanced a propsed state nutrient trading system to reduce cost of wastewater management (AB 113/SB 91)
- Successfully lobbied the Wisconsin Department of Agriculture, Trade, and Consumer Protection to offer key dairy licensing exams in Spanish

In 2019, members of WCMA's Technology Committee held meetings with the Wisconsin Department of Natural Resources, studied new research on denitrification and environmental practices, and toured Mullins Cheese's state-of-the-art wastewater processing facilities.



In partnership with the Center for Dairy Research and Dairy Farmers of Wisconsin, WCMA launched a new group in 2019, called the Dairy Food Safety Alliance. Focused on providing timely updates on regulation and resources for the industry's food safety professionals, the group meets twice annually.
