# SBA, Treasury Set to Release Updated PPP Guidance

In a **joint news release** late yesterday, the U.S. Small Business Administration and the Treasury Department said they will "promptly" issue new Paycheck Protection Program rules and guidance, a modified application form, and a modified loan forgiveness application. Changes are necessary, following the recent signing of the Paycheck Paycheck Protection Program Flexibility Act.

# WDOR Publishes FAQ on Farm Support Program

The Wisconsin Department of Revenue (WDOR) has published a <u>list of frequently asked questions</u> - and corresponding answers - about the new \$50 million Wisconsin Farm Support Program. WDOR estimates 26,500 farms will be eligible for aid payments of between \$1,000-\$3,500. Applications may be submitted online beginning June 15, and must be received by 11:59 p.m. on June 29. Payments will be distributed beginning July 15.



# **DBIA Grant Application Period Begins Monday**

Midwest dairy producers and processors looking to diversify, modernize, or develop new products can <u>submit grant applications to the Dairy Business Innovation Alliance</u> (DBIA) starting Monday, June 15. A grant review committee established by DBIA and including WCMA will make awards for projects in increments up to \$20,000. Applications are due August 14 and selected applicants will be notified in September.

Coordinated as a partnership between the Center for Dairy Research and WCMA, DBIA is available to help dairy-related businesses in Wisconsin, Illinois, Minnesota, Iowa and South Dakota.

DBIA will be distributing direct-to-business grants totaling \$220,000. Grants can be used for a wide variety of projects, including:

- Dairy farm diversification through value-added initiatives, such as development of dairy products or on-farm business ventures
- Modernization, specialization or expansion of farmstead or dairy facilities to support product development or improvement
- Increasing sales of current products through improvement of product quality, packaging and marketing
- Value chain and commodity innovation to develop specialty dairy products
- Ensuring regulatory compliance and quality control to give businesses greater access to the food industry, e.g. to supply local stores and processors

DBIA is funded by the U.S. Department of Agriculture's Dairy Business Innovation Initiatives, a 2018 Farm Bill program championed by U.S. Senator Tammy Baldwin (D-WI) and WCMA. DBIA will also use USDA funding to offer industry training and consultative services. Complete details are available on the <u>DBIA website</u> or by contacting your <u>WCMA staff</u>.

# **WDATCP Announces Processor Grant Recipients**

The Wisconsin Department of Agriculture, Trade and Consumer Protection has announced the <u>2020</u> <u>recipients of the state's dairy processor grants</u>, worth a total of \$200,000. Congrats to WCMA members Agropur, Arena Cheese, Cedar Grove Cheese, Henning Cheese, Moundview Dairy, Nasonville Dairy, and Zimmerman Cheese Company on their successful applications! WCMA actively advocates for this grant program, and in 2020, we gained the support of Governor Tony Evers and many legislative leaders for increased investments in the program in future years.

## WCMA Urges Swift Confirmation of Romanski

In a <u>letter issued to members of the Wisconsin State Senate</u> this week, WCMA is urging swift confirmation of Randy Romanski to serve as Secretary of the Wisconsin Department of Agriculture, Trade and Consumer Protection. In the message, Executive Director John Umhoefer noted Romanski's "steady approach to leadership" and acknowledged the Secretary-designee's "development of the Wisconsin Farm Support Program and Food Security Initiative, as well as his work to address pressing industry needs, including access to personal protective equipment."


