WCMA Applauds New Dairy Innovation Funding



WCMA last week <u>applauded U.S.</u>

<u>Department of Agriculture Secretary Tom Vilsack's announcement</u> of approximately \$11 million in federal funding for four Dairy Business Innovation Initiatives, including the <u>Dairy Business Innovation Alliance</u> (<u>DBIA</u>) run by WCMA and the Center for Dairy Research. <u>READ MORE...</u>

The DBIA offers research and development, technical assistance, education, and grants to dairy businesses in Illinois, Iowa, Indiana, Kansas, Michigan, Minnesota, Missouri, Nebraska, Ohio, South Dakota, and Wisconsin. The current DBIA grant period is open now through October 23, offering grants of up to \$100,000 each.

Farm Bill Extension Expires



Absent Congressional action last week, a one-year extension of Farm Bill funding expired September 30. U.S. Department of Agriculture (USDA) officials say that with a few exceptions, the bulk of their operations have funding to last through the end of 2024. Republicans and Democrats from the agricultural committees have expressed a desire to move quickly on a Farm Bill funding package following Election Day.

FDA to Begin Dairy Plant Silo Testing for H5N1; States May Opt Out



The U.S. Food and Drug Administration (FDA) announced October 3 that it will proceed with a raw milk silo sampling survey for the H5N1 virus, with sampling at dairy processing facilities beginning October 28. The survey is voluntary: individual states can choose to participate in or decline the study. In its October 3 announcement, FDA described this "silo study" as double blind with no information on the origin of each sample vial collected. Samples will be collected only from silos with raw milk intended for pasteurization.

The Wisconsin Department of Agriculture, Trade and Consumer Protection (WDATCP) is currently weighing USDA's request to participate. WCMA has expressed concern to WDATCP leadership about the lack of useful information, and resulting consumer confusion, that a blinded survey with unknown participation will yield.


