#### **Senate Farm Bill Proposal Introduced**



On Monday, U.S. Senator Debbie Stabenow (D-MI) released the Senate Agriculture Committee's <u>Farm Bill draft</u> in a late bid to move the legislation forward during the lame-duck session of Congress. Funding for many key USDA programs will run out on December 31, but it remains to be seen if lawmakers can complete their work on a new Farm Bill package or will opt to extend the 2018 Farm Bill again. Negotiations between the Senate and House have been unproductive thus far, with major disagreements over funding for farm safety net support, conservation efforts, and nutrition programs.

The Senate version of the Farm Bill includes an increase in funding for Dairy Business Innovation Initiatives to \$36 million per year, up from \$20 million. The <u>House version</u>, which was approved in May, simply maintains that level of support.

Also critical to the dairy processing industry, the Senate version expands the existing Healthy Fluid Milk Incentives Projects program to yogurt and cheese offerings, authorizing \$20 million over five years in funding; mandates that USDA execute a biennial cost of production survey to ensure accurate make allowances in federal orders; continues the Dairy Forward Pricing Program through 2029; and adjusts the Dairy Products Donation Program to allow for broader participation.

WCMA is lobbying for member interests as the Farm Bill process continues, and we encourage members to make their voices heard, too. Engage in <u>WCMA's email advocacy campaign</u> this week to join our call for action.

#### **USDA Mandatory Milk Testing to Begin in December**



The U.S. Department of Agriculture (USDA) is moving ahead with a <u>mandatory milk</u> <u>testing program</u>, designed to gauge the prevalence of the disease with the goal of eliminating it.

On a recent call with WCMA staff and other agricultural stakeholders, USDA officials said they expect some mandatory testing to begin in December, continuing into January and February. Some states will be early adopters of the mandatory program, and may be announced as early as this week.

The program will be executed through cooperative agreements, which will include privacy protections to ensure no inappropriate disclosure of business information. USDA will report results at the state level, similar to its current reporting of H5N1 positives, and does not anticipate offering more granular information. The agency can also cover the cost of shipping samples through cooperative agreements and will continue to cover the cost of testing.

USDA (along with the U.S. Food & Drug Administration and National Conference on Interstate Milk Shipments) is also continuing a different, voluntary dairy plant silo testing program. Officials expect that study to be complete in December, likely before the bulk of mandatory testing begins.

#### **New Report Shows \$52.8B Economic Impact of Wisconsin Dairy**

Wisconsin's dairy industry contributed an impressive \$52.8 billion and 120,700 jobs to the state's total industrial revenue, with dairy processing accounting for much of those numbers, according to <u>a new University of</u> <u>Wisconsin report</u>. The report also explores the environmental impacts of Wisconsin's agricultural industries, estimating that the dairy category (both on-farm and processing) contributed seven million metric tons of CO2 equivalent in greenhouse gas emissions in 2022, or approximately five percent of the state's total emissions. **READ MORE...**

#### **USDA Awards Cheddar, Butter Contracts to WCMA Members**

The U.S. Department of Agriculture (USDA) has <u>awarded contracts</u> to WCMA members Associated Milk Producers Inc. (AMPI) and Great Lakes Cheese to provide over 138,000 pounds of cheddar cheese for use in federal food distribution programs. AMPI also <u>secured a contract</u> to provide over 82,000 pounds of butter to USDA.
