#### **Congress Works to Avoid Friday Government Shutdown**



Congressional leaders are working to advance a stopgap bill to avoid a government shutdown, with current funding set to run out on Friday, March 14. House Speaker Mike Johnson on Saturday released a <u>99-page text</u> for a continuing resolution which would largely keep funding for the government at levels set by former President Joe Biden until September.

Johnson will need to hold his caucus together for passage, given their slim majority and reports that some Republicans have already decided to <u>vote against the bill</u>. Democratic support is unlikely, as party leaders have stated that they would need additional guardrails for Elon Musk's Department of Government Efficiency (DOGE) to get on board.

If the bill is approved in the House, it also faces a tenuous future in the Senate, where seven Democrats will be necessary along with the 53-seat Republican majority for approval. Democratic Senator Patty Murray of Washington, the ranking member of the Senate Appropriations Committee, on Saturday <u>expressed strong concerns</u> about the package, connected to DOGE cuts.

#### **Trump Reverses Course on Some Tariffs; Doubles Others**



President Donald Trump on Thursday reversed some, but not all, of the 25 percent tariffs he enacted earlier this month on Mexican and Canadian goods shipped to the United States. Tariff <u>delays announced</u> <u>last week</u> are expected last through April 2 for products that are in compliance with the U.S.-Mexico-Canada (USMCA) free trade treaty. However, only around 50 percent of the goods the U.S. imports from Mexico and 38 percent of the goods from Canada comply with USMCA terms.

In addition, President Trump is threatening to enact a 250 percent tariff on Canadian dairy, and 50

percent tariffs on all steel and aluminum imports are set to take effect on March 12.

Also this week, <u>China's retaliatory tariffs</u> against <u>U.S. agricultural products</u>, including a ten percent tariff on dairy products, took effect Monday. Canadian Premier Doug Ford <u>enacted a 25 percent tariff</u> on electricity exports to the U.S. on Monday, estimating that it would add almost \$70 to the monthly bills of many homes and businesses in New York, Michigan, and Minnesota, and Canadian leadership are promising other retaliation soon.



#### USDA Releases DBI Funding Following Industry Advocacy

WCMA last week <u>applauded news</u> that the U.S. Department of Agriculture (USDA) released Congressionally-directed funding for the federal Dairy Business Innovation (DBI) Initiatives.

USDA froze DBI grant monies two weeks ago, triggering grave concern for hundreds of dairy farmers and processors nationwide. WCMA sent a letter to USDA Secretary Brooke Rollins on <u>February 26</u> urging her to release the funding. A <u>second</u> <u>letter</u> on March 3 was signed by 120 dairy businesses from 29 states.

In addition, <u>WCMA Senior Director of Programs & Policy Rebekah Sweeney</u> led a coalition of dairy processors and industry partners in more than a dozen advocacy meetings with Congressional leaders in Washington D.C. Many thanks go to WCMA members Land O'Lakes, Organic Valley, and Sargento Foods; DBI partner The Old Stone Creamery; and the International Dairy Foods Association for joining WCMA for this in-person effort.

#### **U.S. Dairy Exports Start 2025 with Continued Gains**

Almost all categories of U.S. dairy exports saw increases in January 2025, offsetting shortfalls in nonfat dry milk/skim milk powder and lactose, according to recent <u>analysis by the U.S. Dairy Export</u> <u>Council</u>. Cheese exports performed particularly well, with year-over-year volume increasing for the 13th consecutive month and growth occurring in diverse markets including Japan, Panama, and Bahrain. Butterfat exports from U.S. dairy manufacturers also rose an impressive 145 percent year-over-year. **READ MORE...**
