USDA Planning Mass Layoffs, Encourages "Deferred Resignation"



The U.S. Department of Agriculture (USDA) notified agency personnel via email last week that another round of layoffs is coming, encouraging workers to accept a "deferred resignation program" by close of business today, offering them paid leave through September. The agency is also offering early retirement to certain employees. READ MORE...

USDA Secretary Brooke Rollins has not yet provided details on the layoffs, saying instead that the agency cannot offer "full assurance regarding which positions will remain—or where they will be located —after USDA's restructuring." Nearly 6,000 probationary workers were fired at the USDA in February and then brought back in recent weeks under court order.

Proposed New Tariffs Trigger Global Escalation Against U.S.



President Donald Trump's <u>sweeping new</u> <u>tariffs</u> on U.S. imports, announced Wednesday, April 2 and detailed in a <u>WCMA member alert</u>, are triggering responses from some of the nation's key trading partners – which may also mean an escalation of action from the White House.

Trump today proposed an additional 50 percent tariff on Chinese goods, on top of the 34 percent he announced last week against the world's second-largest economy. <u>His message</u> is a reaction to <u>Chinese officials' announcement</u> on April 4 of a matching 34 percent blanket tariff on all U.S. imports, including dairy, an amount matching Trump's original tariff on goods from China. China is vowing a <u>"fight to the end"</u> on tariffs.

The 27-country European Union rolled out its <u>first set of counter-measures</u> last night, offering a "zero-for-zero" tariff deal to Washington, but also proposing retaliatory tariffs of 25 percent on a range of U.S. imports, notably excluding dairy. Mexico and Canada were <u>left off</u> Trump's new global tariffs list but levies up to 25 percent have already been <u>imposed</u> on automobiles, steel, aluminum, as well as on goods that do not comply with the USMCA trade pact. While Mexican officials are not ruling out retaliatory tariffs, they are working to negotiate first with the U.S. Canada has, however, imposed 25 percent tariffs on \$50 billion worth of U.S. goods, plus new auto tariffs on all imports from the U.S.

Brazil's Congress <u>reacted</u> to Trump's tariffs by passing a law enabling trade retaliation, with action yet to come. Great Britain, India, Japan, South Korea, Taiwan, and Vietnam have announced no immediate counter-measures, instead sending teams to negotiate concessions from the U.S.




