
### **Biden Administration Accomplishments**


Partisan & Bipartisan Legislation

- American Rescue Plan (2021)
  - Passed with only Democrat support through Budget Reconciliation
- Infrastructure Investment and Jobs Act (2021)
  - Bipartisan support in the House and the Senate
- Inflation Reduction Act (2022)
  - Passed with only Democrat support through Budget Reconciliation

## **Key story lines for 118th Congress**

- In the House...
  - -Speaker McCarthy
    - Only 1 House Republican needed to trigger a "motion to vacate"
    - Can only lose 5 Republican votes on bills
    - And yet...
      - House Republicans have generally stayed together....
      - But Democratic House votes are also important....
        - Debt Ceiling deal 314-117 with 70 Republicans voting "no"
        - What does Impeachment Inquiry mean for bipartisanship?


## **Key story lines for 118th Congress**

- In the Senate...
  - -51-49 Democratic Majority
    - 3 Independents
  - -Judges have been moving
    - Biden 143 to Trump 153 at the point in the Presidency

#### **Turbulence Ahead?**

- Prescription Drug Pricing
  - Inflation Reduction Act impact on Medicare drug prices
    - Price increases cannot be higher than inflation
    - Medicare can start negotiating the price of certain high cost drugs in 2026
    - Together, by 2030, could save Medicare \$31 billion per year
    - Neither of these provisions apply to the commercial market

### **Legislative Agenda**

#### Government Shutdown

- Spending bill needed by September 30
  - Short term spending bill through December?

#### PBM Reform

- Eliminate Spread Pricing for Medicaid
- New reporting requirements from PBMs to Employers

#### Section 45S Paid Leave Tax Credit Enhancement

- Make credit permanent
- Allow a tax credit for Short Term Disability premiums paid by employers
  - Provide coverage to all employees (full and part time)
  - Tax credit only "counts" employees making under \$90,000

## **Regulatory Agenda**

- Mental Health Parity
  - ERISA Advisory Council reviewing LTD Plan design flexibility
- Supplemental Health Products Proposed Rule
  - When paid with pre-tax premium, all benefit payments would be taxable
  - Increase required disclosures



## Most states are governed by one party



#### **Dental Loss Ratios**

- Massachusetts becomes first state with an ACA style dental loss ratio
  - -2015: California creates dental loss ratio reporting
  - -2022: Maine creates dental loss ratio reporting
- November 8<sup>th</sup>, Massachusetts voters over-whelming supported the creation an 83% minimum dental loss ratio for fully insured plans
  - Effective for plans sold or renewed starting 1/1/24
  - -Milliman anticipates rate increases by as much as 38%
- Which state is next?
  - Reporting has been the industry position
  - -We anticipate this issue will continue for the foreseeable future

## Paid Family & Medical Leave / Paid Family Leave

- 13 states and DC either currently or will have a statutory PFML program:
  - CA, NY, NJ, RI, DC, WA, MA, CT, OR, CO, MD, DE, MI, and ME
    - All but DC and RI allow for a "private plan"
  - Michigan, and New Mexico are all exploring statutory PFML programs
- New Hampshire and Vermont states have created "voluntary" Paid Family Leave state programs
- Arkansas, Alabama, Florida, Tennessee, and Virginia now allow insurers to sell a fully insured Paid Family Leave product
  - Industry is looking for more states to adopt this legislation

#### **ESG** Issues

- Fossil fuel investment restrictions
  - Four states restrict government contracts if companies "boycott" fossil fuel companies
    - Arkansas, Oklahoma, Texas, and Utah

- Gun manufacturer discrimination
  - -Six states restrict government contracts if companies "discriminate" against gun manufactures
    - Arkansas, Montana, Texas, South Dakota, Utah and Wyoming



On day 980 of their Presidency, their favorability rating was...


