

CHAPTER PERFORMANCE UPDATES

Events Scheduled April 1, 2024 – March 31, 2025 = 152 (+33 since 5/16!)

- 51% to goal of 300 events
- 2,716 attendees from 1,276 companies
- 712 nonmember event registrants
- 185 Event Feedback surveys received since 4/1

Overall, how would you rate the event?

CHAPTER REMINDERS

CHAPTER EVENT FEEDBACK SURVEY

WiM's <u>Chapter Event Feedback Survey</u> should be sent to registrants within 48 hours of each chapter event, to ensure accurate feedback is captured and participation in the survey is maximized. To ensure the results are measurable, the survey itself must remain consistent across all WiM Chapter events.

LATE OR LAST-MINUTE EVENT REGISTRANTS

Once registration for a chapter event has closed, late registrations must be tracked by the chapter, then communicated to WiM National after an event is complete. The only instance where it would be necessary for WiM the register attendees from the backend before an event is if the event is for members-only and the chapter has nonmembers who should be able to attend.

ACCESS EVENT REGISTRANT LISTS & CHAPTER ROSTERS ON-DEMAND

Chapter leaders can now access their chapter's event registrant lists and member rosters on-demand via the WiM website! With this update in mind, WiM National will no longer proactively provide event registrant lists or chapter member rosters. Instead, leaders can access and export these reports via their WiM member compass. Instructions for accessing these reports can be downloaded in the Chapter Resource Hub.


CHARGING CREDIT CARD FEES TO CHAPTERS

Historically, WiM has charged chapters for the credit card fees associated with individual registrations for their events as well as sponsorships. Effective June 2024, WiM will no longer charge back credit card fees to chapters for transactions that are under \$500. If a transaction is \$500 or more, the chapter will be charged the credit card fee for the transaction, which is approx. 3% of the total charge.

CHAPTER EXPENSE REPORTS DUE

Each chapter cardholder must submit a monthly expense report and all relevant receipts to their chapter's Treasurer. Please note: Treasurers are not able to view transactions on Chase ONE cards for other leaders from their chapter; cardholders can view their own transactions only. Chapter expense reports for the previous month should be submitted by the Treasurer within the first two weeks of the following month. May 2024 expense reports due from chapters ASAP; May 2024 transfer files from WiM National will be sent the 3-4 week of this month.


