



- Attendees will pay the event venue for alcohol directly; The chapter is not purchasing alcohol for attendees. Α.
- Attendees will pay the chapter to register, then the chapter will pay the venue for alcohol. Β.
- Attendees will pay chapter, then the chapter will buys and/or serves alcohol to attendees directly C.

If B and/or C are selected, then you will be asked:

What is the estimated total revenue to be collected for alcohol sales? Note: This is the amount the chapter expects to spend on alcohol for the event?

What is the minimum liability insurance required by the event venue? Note: The venue should be able to provide this information.






