

Visitor Policies, Release Form and Waiver of Liability

In consideration of being granted the right to visit Norix Group, Inc., I acknowledge, agree and represent that I am aware that the company site is a potentially dangerous environment, despite the precautions for safety taken by the company. I further agree and warrant as follows:

- 1. To the fullest extent permitted by law, I hereby release, waive, discharge and covenant not to sue the company, its individual officers, administrators, employees and agents, acting officially or otherwise, from any and all liability, arising from my negligence or otherwise, as a result of my visit to the site, including, but not limited to, liability for property damage or loss, or bodily, personal or mental injury, including death. I understand that visitors with pacemakers should not enter the production area.
- 2. I further agree to hold harmless and indemnify the company against any liability arising from my negligence or otherwise and from damages of any kind as a result of my participation in visiting the site.
- 3. I acknowledge that it is my sole responsibility to evaluate carefully the risks inherent in visiting the site and that I have fully considered those risks, including, without limitation, dangers posed by willful or negligent conduct of myself and/or by others.
- 4. I acknowledge and voluntarily assume full responsibility for, and full risk of, property damage or loss, or bodily, mental, or personal injury, including death, relating to my participation in the visit to the site.
- 5. I acknowledge that I am not an employee of the company or any of its agents.
- 6. I agree that if any portion of this document is held invalid, the remaining provisions shall be binding and continue in full force and effect.
- 7. I acknowledge that the site visit and its activities have been explained to me, and all of my questions answered to my complete satisfaction.

- 1. All visitors must acknowledge and agree to these policies.

- 7. No weapons are allowed in the facility at any time.
- 8. No pictures or video can be taken in our production areas.
- 9. All packages, boxes, or cases are subject to search upon request.
- 10. **VISITORS WITH PACEMAKERS** should **NOT** enter the production area.

It is the intention of the parties that this agreement and its performance and all suits hereunder be construed under the laws of the State of Illinois without regard to the jurisdiction in which any suit may be instituted.
